The Greene County Prison Board meeting was brought to order at 11:45 am by Chairman Mike Belding in the first-floor meeting room of the County office building. Others in attendance were: Commissioner Betsy McClure, Commissioner Blair Zimmerman, Chief Clerk Jeff Marshall, Sarah Penich, Ami Cree, Warden John Kingston, Jerad Cline, and Dave Russo

### **MOTIONS**

1. Commissioner Betsy McClure made the motion and Commissioner Blair Zimmerman the second to approve the minutes from the March 18th 2021 Prison Board meeting. Vote unanimous.

### **SECURITY**

1. There were nine (9) reportable Extraordinary Occurrence Report (EOR) submitted to the Pennsylvania Department of Corrections for the Month of March 2021.
2. The facility issued twelve (12) major misconducts and thirty-eight (38) minor misconducts for the month of March 2021.

### **TREATMENT**

1. On 04-20-21, several Inmates and staff members received the Pfizer vaccine at the facility. This vaccine was offered through the Washington Health Care System in lieu of the previously

scheduled Johnson and Johnson vaccine.

2. This Sunday we will begin broadcasting video church services from the Landmark Baptist Church via our Tele-Communication system located in the Conference Room. These service viewings will be offered to the various Housing Units at several times throughout the day.

### **STAFFING AND TRAINING**

1. Mr. Jason Stevens has started as the new Food Service Worker on 04-19-21.

### **MAINTENANCE**

1. With the final approval of a structural assessment completed on 04-13-21, demolition has begun in the former non-contact visiting room. The material cost required to construct the projected three (3) security holding cells will be at or around \$1,900.00. This project will be completed with support from County Maintenance in regards to the required masonry and structural aspects and the Work Crew. Funding for this renovation project will be accessed under Maintenance and Repairs budget item #63215.

### **FINANCIAL REPORT**

1. The March assessed revenue report generated from the Greene County Central Booking Center was \$8,225.00 with \$3,216.48 being an actual paid return for the month.
2. The Inmates have been notified as of 04-21-21 via the Cell Cast video system that effective 06-01-21 that fees will be assessed for specific administrative functions and or requested services at the facility.
