GREENE COUNTY PRISON BOARD MINUTES

March 17 2022

The Greene County Prison Board meeting was brought to order at 12:00 pm by Chairman Mike Belding at the Greene County Prison. Others in attendance were: Commissioner Betsy McClure, Commissioner Blair Zimmerman, Jeff Marshall, Warden John Kingston, Deputy Warden Jerad Cline, Ami Cree, Marcus Simms, and Zackery Howard. The Minutes from 2-17-22 were motioned for approval by Commissioner McClure and 2nd by Commissioner Zimmerman. The vote was unanimous for approval of the minutes. Adjournment was motioned by Commissioner McClure and 2nd by Controller Cree. The vote to adjourn was unanimous.

MOTIONS

1. To approve the meeting minutes from the February 17 2022 Prison Board meeting.

SECURITY

1. There were ten (10) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the month of February 2022.
2. The facility issued twenty (20) major misconducts and forty-one (41) minor misconducts for the month of February 2022.
3. The average daily population for February was seventy-nine (79) with seventy-one (71) being the lowest number and eighty-eight (88) being the highest.

TREATMENT

1. During the month of February, Landmark Baptist Church conducted four (4) Bible study groups, Celebrate Recovery also ran four (4) Men's Bible study sessions and First Assembly Church had three (3) Women's Bible study groups.
2. The facility also hosted four (4) Narcotics Anonymous meetings, three (3) Parenting groups, and one (1) Haircut session.
