GREENE COUNTY PRISON BOARD AGENDA

May 12 2022

The Greene County Prison Board meeting was brought to order at 11:45 am by Chairman Mike Belding in the County Building in the 1st floor conference room. Others in attendance were: Commissioner Betsy McClure, Commissioner Blair Zimmerman, Chief Clerk Jeff Marshall, Warden John Kingston, and Megan Phillips. The Minutes from 3- 17-22 were motioned for approval by Commissioner McClure and 2nd by Commissioner Zimmerman. The vote was unanimous for approval of the minutes. Adjournment was motioned by Commissioner McClure and 2nd by Commissioner Zimmerman. The vote to adjourn was unanimous.

MOTIONS

1. To approve the meeting minutes from the April 21 2022 Prison Board meeting.

SECURITY

1. There were fourteen (14) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the month of April 2022.
2. The facility issued fifteen (15) major misconducts and twenty-one (21) minor misconducts for the month of April 2022.
3. The average daily population for April was seventy-one (71) with sixty-two (62) being the lowest number and eighty-six (86) being the highest.

TREATMENT

1. During the month of April, Landmark Baptist Church conducted three (3) Bible study groups, Celebrate Recovery also ran four (4) Men's Bible study sessions and First Assembly Church had seven (7) Women's Bible study groups.
2. The facility also hosted five (5) Narcotics Anonymous meetings, three (3) Parenting groups, two (2)

STAFFING AND TRAINING

1. We have three (3) new Corrections Officers starting this month, one will start on the 16th and the other two on the 23rd. These new hires will cover existing and pending vacancies due to staff transfers to the PA DOC.

MAINTENANCE

1. The County established bids for the Fence Enhancement project opening May 9 2022.
2. Wire has been placed for the Camera Upgrade project pending reception of the new cameras.

FINANCIAL REPORT

1. The April assessed revenue report generated from the Greene County Central Booking Center was \$4,200.00 with an actual paid return for the month of \$1,654.86
2. The administrative fees assessed for April were \$ 1270.00 with \$ 402.33 being collected.
3. Washington County currently owes \$9,550.00 for April rentals.
